I, (b)(6), (b)(7)(C), make the following free and voluntary statement to (b)(6), (b)(7)(C) whom I know to be a Special Agent of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge of the death of Admiral Jeremy Michael Boorda, USN.

For the purpose of identification, I am a _____ male, _____ inches tall, weighing approximately _____ pounds. I have _____ hair and _____ eyes. My social security number is _____ and I was born on _____

On or about 1330 hours, while I was sitting in my office at the Naval Historical Center, I observed from the window, a white male in civilian attire (suit) running out from Admiral Boorda's driveway in a full sprint. I then saw the same gentleman, with a white male Navy Lieutenant who I later learned was _____ running back toward the driveway of the Admiral's residence. At that point, I notified a coworker, _____ that something didn't look right. I proceeded to leave the Historical Center and head over to the Admiral's residence. I heard a commotion (men yelling) coming from the garden located in the Admiral's residence. I made my way back to the garden and observed _____ performing CPR on Admiral Boorda. I made my way to the scene to see if I could provide assistance by way of CPR/First Aide. I noted what appeared to be a gunshot wound in the center of Admiral Boorda's chest. I looked around and saw what appeared to be a 357 laying nearby. I asked a Naval District Washington Police Sergeant who was at the scene at that point to secure the weapon so as it would not be handled by anyone. I then held the Admiral's hand and said a silent prayer. Shortly thereafter, I was overcome with an acute sense that it was taking much too long for medical help to arrive. At this point I made my way out to the front of the residence and noticed the way for the ambulance blocked by dozens of marked and unmarked police cars. I began yelling to a police officer to clear a path for the ambulance and he told me to "Calm down. We could have a bird cage situation." He was under the impression that the Admiral was in the house. However, I informed him that "No, the Admiral is laying outside in the yard and needs medical attention immediately. Let them through now."

At this point, the scene was chaotic with police officers everywhere. I went back and stayed with _____ for approximately 90 minutes. We watched the activities from a distance and were approached by officers at various times who asked us what our role was. AN officer finally came and

asked (b)(6), (b)(7)(C) to leave with him. I then gave (b)(6), (b)(7)(C) my full name and number should he need me and I left the scene. This was approximately 90 minutes after my arrival. (b)(6), (b)(7)(C)

I, _____ make the following free and voluntary statement to (b)(6), (b)(7)(C) whom I know to be a Special Agent of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge of .

For the purpose of identification, I was born in (b)(6), (b)(7)(C) My social security number is (b)(6), (b)(7)(C) and since (b)(6), (b)(7)(C), I have been (b)(6), (b)(7)(C) to the Chief of Naval Operations.

ON 16MAY96, (b)(6), (b)(7)(C) USN, WAS THE DUTY AIDE TO ADMIRAL BOORDA. BETWEEN APPROXIMATELY 1000 AND 1150, I WAS AT THE CNO'S RESIDENCE, TINGEY HOUSE IN THE WASHINGTON NAVY YARD, OVERSEEING WORK BEING DONE ON THE FIRE ALARM FOR THOSE QUARTERS. I GOT BACK TO MY OFFICE IN THE PENTAGON FROM TINGEY HOUSE AT ABOUT 1205 ON 16MAY96. I DID NOT HAVE OCCASION TO SEE ADMIRAL BOORDA AT ALL ON 16MAY96. NORMALLY THE CNO CAME INTO WORK EACH DAY AT ABOUT 0635, BUT FOR SOME REASON HE DECIDED TO COME IN LATER DURING THE MORNING OF 16MAY96. WHILE WORKING ON THE ALARM AT TINGEY HOUSE, I DID ASK (b)(6), (b)(7)(C) USN, WHO IS ASSIGNED TO THE RESIDENCE, WHAT ADMIRAL BOORDA HAD BEEN DOING THAT MORNING IN THE HOME. (b)(6), (b)(7)(C) SIMPLY TOLD ME THAT THE CNO HAD BEEN WORKING THE MORNING AWAY IN HIS OFFICE THERE. (b)(6), (b)(7)(C) GAVE NO HINT OF ANYTHING HAVING BEEN AMISS OR OUT OF THE ORDINARY, WHILE THE CNO WORKED ALONE AT HOME THAT MORNING. WHILE AT TINGEY HOUSE, I WAS JOINED AT ABOUT 1030 BY (b)(6), (b)(7)(C) NAVY PUBLIC WORKS CENTER, WHO IS THE (b)(6), (b)(7)(C) WAS IN THE HOME WHEN I FIRST GOT TO TINGEY HOUSE, BUT SHE DEPARTED BETWEEN 1020 AND 1030 FOR (b)(6), (b)(7)(C)'S HOME. WE HAD TO TEST THE ALARM BELLS AT TINGEY HOUSE, BUT DID NOT DO SO UNTIL AFTER (b)(6), (b)(7)(C) DEPARTED THE HOME THAT MORNING. BY THE TIME I ARRIVED AT TINGEY HOUSE, THE CNO HAD ALREADY DEPARTED FOR HIS OFFICE AT THE PENTAGON. AT ABOUT 1400 ON 16MAY96, AT THE REQUEST OF (b)(6), (b)(7)(C) I DID CALL THE MARINE GUARD POST AT LATROBE GATE, WASHINGTON NAVY YARD, AND WAS TOLD THAT ADMIRAL BOORDA HAD BEEN SHOT IN THE CHEST. I PUT THE TELEPHONE DOWN AND IMMEDIATELY REPORTED TO THE EXECUTIVE ASSISTANT WHAT I HAD JUST BEEN TOLD.

IN THE DAYS LEADING UP TO THIS INCIDENT, I HAD DONE SOME EXTENSIVE TRAVELING WITH THE CNO, BUT NEVER NOTICED HIM TO BE OUT OF SORTS BY WORD OR DEED. I RECALL THAT ON TUESDAY, 14MAY96, THE CNO AND I WERE BEING DRIVEN BY (b)(6), (b)(7)(C) USMC, FROM THE PENTAGON TO HIS QUARTERS, WHERE (b)(6), (b)(7)(C) OF THE NAVAL DISTRICT WASHINGTON POLICE DEPARTMENT, WAS TO

BRIEF US ON THE SECURITY ALARM SYSTEM FOR TINGEY HOUSE. ADDITIONALLY, HE WAS TO BRIEF THE CNO ON UP-GRADES TO THE CURRENT SECURITY SYSTEM. ON THE DRIVE OVER TO THE NAVY YARD, ADMIRAL BOORDA JOKED THAT IF AN INTRUDER EVER GOT INTO TINGEY HOUSE, HIS DOG DUKE WOULD HAVE TO HOLD THE PERSON DOWNSTAIRS WHILE THE CNO WENT UPSTAIRS TO GET HIS PISTOL OUT OF THE SAFE (COMMENTING ON THE AMOUNT OF TIME IT WOULD TAKE TO DO THIS).

ON THE DAY OF 15MAY96, EVERYTHING WAS COMPLETELY NORMAL ABOUT THE OFFICE. I DO NOT HAVE ANY IDEA WHY THE CNO WOULD HAVE TAKEN HIS OWN LIFE. ADMIRAL BOORDA ALWAYS HAD THE QUICK AND CORRECT SOLUTION TO EVERY PROBLEM.

FROM ABOUT 1700 UNTIL 1800 ON 16MAY96, I ESCORTED (b)(6), (b)(7)(C) (b)(6), (b)(7)(C) FROM TINGEY HOUSE TO HER HOME IN FAIRFAX COUNTY, DURING THIS DRIVE, (b)(6), (b)(7)(C) TOLD ME THAT (b)(6), (b)(7)(C) HAD NOT BEEN HIMSELF AT HOME FOR ABOUT A WEEK AND A HALF LEADING UP TO HIS DEATH. RECALLED THAT WHEN HER FAMILY VISITED TINGEY HOUSE THE WEEKEND OF 04/05MAY96, ADMIRAL BOORDA, IN A MANNER UNCHARACTERISTIC OF HIMSELF, JUST LAYED ABOUT THE COUCH. TOLD ME THAT THE MEDIA HAD NOT ONLY BEEN DIGGING FOR INFORMATION ABOUT ADMIRAL BOORDA, BUT SOME HAD EVEN GONE SO FAR AS TO LOOK INTO HER BACKGROUND AND THAT OF

I CAN NOT THINK OF ANY OTHER INFORMATION AT THIS TIME WHICH WOULD BE RELEVANT.

_____, as background, _____ having _____ on 10Jul93. My wife and I are frequent visitors at Admiral Boorda's house on the Navy Yard.

About six months ago, I offered Admiral Boorda a personal five-shot revolver for his own residential security aboard the Navy Yard. I had lawfully purchased the revolver in the late 1980's. Admiral Boorda accepted my offer and I loaded the weapon with five hollow-point bullets. I am uncertain as to where I originally obtained the bullets. Admiral Boorda stated he would secure the weapon in his CNO residence office (study). To my knowledge, he was the only person who knew where the weapon was located, and I was confident he would store and handle it properly.

On 16May96, I was promptly informed that Admiral Boorda had been shot in the chest at his residence. I immediately responded to the scene from my office at the Navy Yard and was met by a Washington, DC, homicide detective. I identified the revolver at the scene as the aforementioned five-shot revolver I had lent to Admiral Boorda. _____ was not at home. I knew she was going to my residence to visit with my wife. Subsequently, I knew that Admiral Boorda frequently worked in his study in the residence and I went by myself to the study and found two typewritten (printed) notes that I quickly realized pertained to Admiral Boorda's death. I did not touch them or move them. I went outside the residence and immediately notified NCIS as to the presence of the notes. I then escorted NCIS to the study where the notes were located.

I, (b)(6), (b)(7)(C), (b)(6), (b)(7)(C), make the following free and voluntary statement to (b)(6), (b)(7)(C) whom I know to be a Special Agent of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge of AMPLIFYING INFORMATION CONCERNING THE DEATH OF ADMIRAL J. M. BOORDA, USN.

For the purpose of identification, I am a (b)(6), (b)(7)(C) male, (b)(6), (b)(7)(C) tall, weighing approximately (b)(6), (b)(7)(C) pounds. I have (b)(6), (b)(7)(C) hair and (b)(6), (b)(7)(C) eyes. My social security number is (b)(6), (b)(7)(C) and I was born on (b)(6), (b)(7)(C) I am employed as a Special Agent with the Naval Criminal Investigative Service.

On 16May96, upon notification of a shooting at Tingey House, Washington Navy Yard, Washington, DC, I proceeded to the scene from my employment at NCISFO, Washington Navy Yard. Although I have no specific recollection of the time, I believe I arrived on the scene at approximately 1415, 16May96. I spoke with Metro Homicide Detective (b)(6), (b)(7)(C) and after identifying myself, he led me to the scene of the shooting in the backyard of Tingey House. I observed my personal five shot Smith and Wesson revolver on the ground near a patch of blood on the lawn. Admiral Boorda, (b)(6), (b)(7)(C) was enroute to the hospital via ambulance at that time.

The aforementioned gun, serial number AYV 2602, was legally purchased by me in 1988 through a licensed federal firearms dealer. The purchase was facilitated by and sent to (my former) NISRA, Seattle, WA. While the gun was purchased with my personal finances, I was authorized by the Special Agent In Charge, NISRA Seattle, WA to carry it on duty in accordance with NCIS policy.

Approximately six months ago, I offered the aforementioned five-shot revolver to (b)(6), (b)(7)(C) for his personal protection. He accepted the weapon and kept it secured in his Tingey House office. For the record, Admiral Boorda never gave me any indication he would one day end his life by committing suicide. I have no other information to provide at this time.

I have read and understand this one page typed statement prepared by me. I have made any/all corrections I desire and have initialled these corrections. This statement is true

INVESTIGATIVE ACTION: REVIEW OF TELEPHONE RECORDS

On 04Jun96, telephone records from the Chief of Naval Operations (CNO's) Office were received from Single Agency (b)(6), (b)(7)(C) Pentagon Information Technology Services. The telephone records reflect three telephone calls of interest that were made on 16May96. The first telephone call of interest was placed at 1321 originated from telephone number (b)(6), (b)(7)(C) to (b)(6), (b)(7)(C). The caller was (b)(6), (b)(7)(C) CNO Staff and the receiver of the telephone call was (b)(6), (b)(7)(C) USN, Mess Specialist, CNO residence/Tingey House. Reportedly, V/BOORDA also picked up the telephone during this conversation and said "Hello." Additionally, it was gleaned from interviews V/BOORDA stayed on the line for approximately one minute. The telephone call lasted 10 minutes and 22 seconds.

The second telephone call of interest was made at 1323 originated from telephone number (b)(6), (b)(7)(C) to (b)(6), (b)(7)(C). The caller was (b)(6), (b)(7)(C) to CNO, and the receiver was a pager number belonging to (b)(6), (b)(7)(C) for CNO. A separate investigative action will document (b)(6), (b)(7)(C) telephone call to (b)(6), (b)(7)(C).

The third telephone call of interest was made at 1410 originated from telephone number (b)(6), (b)(7)(C) to (b)(6), (b)(7)(C). The caller was (b)(6), (b)(7)(C) to CNO, and the receiver was (b)(6), (b)(7)(C) USMC, Latrobe Gate/Post #2, WNY. The telephone call resulted in (b)(6), (b)(7)(C) informing (b)(6), (b)(7)(C) of V/BOORDA being shot.

I, (b)(6), (b)(7)(C), make the following free and voluntary statement to (b)(6), (b)(7)(C) whom I know to be a Special Agent of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge of the death of ADM Jeremy Michael Boorda, USN.

(b)(6), (b)(7)(C) For the purpose of identification, I am a male, (b)(6), (b)(7)(C) tall, weighing approximately (b)(6), (b)(7)(C) pounds. I have (b)(6), (b)(7)(C) hair and (b)(6), (b)(7)(C) eyes. My social security number is (b)(6), (b)(7)(C) and I was born on (b)(6), (b)(7)(C)

I was assigned as (b)(6), (b)(7)(C) to Admiral Boorda for approximately five years. Previously, I served a tour of duty with Admiral Boorda in Naples, Italy. One of many duties at the residence is to clean the study. I did not clean the study on 16May96. Usually, I clean the study every morning. On 16May96, I arrived at Admiral's Boorda's residence at approximately 0700. At or around 0745, (b)(6), (b)(7)(C) informed me not to bother Admiral Boorda because ne was working in his study. I did not clean the study due to (b)(6), (b)(7)(C)s request not to disturb the Admiral. In the past, I noticed Admiral Boorda's computer located in the study was always turned off when I was cleaning the room. I did not see Admiral Boorda during this time frame. I learned Admiral Boorda departed the residence at approximately 0930, on 16May96. I did see (b)(6), (b)(7)(C) depart from the residence some time after Admiral Boorda had departed. At that time, (b)(6), (b)(7)(C) was up on the third floor. We meaning myself and (b)(6), (b)(7)(C) USN, also a (b)(6), (b)(7)(C) assigned to Admiral Boorda's residence, are not allowed to go up to the second floor until authorized by (b)(6), (b)(7)(C) Other than (b)(6), (b)(7)(C) and myself, no one else was at the residence

Later, I am not sure of the exact time, but in was during the early afternoon of 16May96, I went to the Navy Federal Credit Union aboard Washington Navy Yard. When I returned I noticed the Admiral's official vehicle parked in the driveway. I did not see the driver at this time. I went into the residence and (b)(6), (b)(7)(C) informed me Admiral Boorda had arrived and was upstairs in his study. (b)(6), (b)(7)(C) remarked not to bother or disturb Admiral Boorda, nothing more.

Next, at approximately 1330-1400, I had to go to the Commissary located aboard Bolling Air Force Base, Washington, DC. When I walked out of the residence, I observed the

USMC, sitting in the driver's seat of Admiral Boorda's official vehicle in the driveway. I was also aware that (b)(6), (b)(7)(C) had turned the vehicle around from where I initially had observed it. RESULTS OF EXAMINATION:

Item #1A is a caliber .38 Special cartridge case, Winchester brand, which was identified as having been fired in the Item #1 revolver.

Item #24 is a caliber .38 Special or .357 Magnum lead bullet, which was fired from a barrel rifled with five (5) grooves, right twist. Although the rifling impressions on Item #24 are like those produce by the Item #1 revolver, it has insufficient individual microscopic markings present to identify or eliminate it as having been fired from the Item #1 revolver.

Items #1B, 1C, 1D and 1E are four (4) caliber .38 Special cartridges, Winchester brand.

Item #19 is a white T-shirt with one (1) hole on the front surface and one (1) hole on the back side. The area around these holes were microscopically examined and chemically processed for the presence of gunshot residues. Residues were found which are consistent with the passage of a bullet.

Item #20 is a white uniform shirt which has three (3) holes. One (1) hole located on the left front placket, one (1) hole located on the right front placket and one (1) hole located center of back. The area around these holes were microscopically examined and chemically processed for the presence of gunshot residues. Residues and physical effects consistent with a contact shot were found on the two hole located on the front placket. Residues were found which are consistent with the passage of a bullet through the hole in the center of back.

Item #21 is a black uniform jacket which has a hole located in the center of back. The area around this hole and an area on the front of the jacket were micropically examined and chemically processed for the presence of gunshot residues and a pattern of residues were found.

EXTERNAL EXAMINATION

The body is received nude and is that of a 5 foot, 7 inch in height, 140 lb., well developed, well nourished, White male whose facial appearance is consistent with the recorded age of 56 years. The body has been refrigerated over night and is cool to the touch with full rigor mortis developed and fixed livor mortis on the posterior surface of the body. Prior to the examination, clothing removed by hospital personnel are received and are examined. Clothing received consists of brief style underwear, white socks, white uniform pants which have been cut away, white shoes and one surgical towel and one surgical gauze piece is received in a bag. Clothing in custody of the Mobile Crime Unit is also received and consists of a white short sleeve uniform shirt and an undershirt. The uniform shirt is remarkable for gunshot wound damage on the placket portion which is discolored a charcoal gray and consists of melted polyester material in a circular fashion surrounding the gunshot defect. The buttons on the shirt are intact and are not fragmented. The defect occurs in the midline of the shirt, on the front with a small slit in the back of the shirt where the projectile exited the body. Examination of the shirt is consistent with gunshot wound pathway in a front to back direction.

The head is normal cephalic and atraumatic covered by straight gray mixed with brown hair which measures up to 2 inches in length. The hair is closely shorn along the sides in the back of the head. The facial hair is cleanly shaven. The irides are brown and the pupil diameters are 3 mm bilaterally. The conjunctivae are clear. There is no evidence of arcus senilis and there are no petechial hemorrhages within the conjunctival surfaces. The nasal bones are palpably intact. There are no palpable fractures to the facial bones or skull. The nares are intact and lined by a pale tan mucosa. There are no abnormalities noted of the nasal septum. Dentition is natural with restorations in both upper and lower alveolar ridges. The buccal mucosa is unremarkable. There are no lacerations to the upper or lower frenula. The tongue is free of bite marks. An endotracheal tube has been inserted orally. There is no tablet or pill residue within the oral cavity and there is no obstruction by foreign objects. The external auditory canals are patent and contain no unusual fluids. The ears are well formed. The neck is unremarkable externally without ligature or furrow markings. There are no unusual scars on the neck. The chest is remarkable for a left thoracotomy incision which measures 7-1/2 inches in length, in a horizontal location and is loosely sutured with coarse material. There is a gunshot wound present in the center of the chest at the level of the nipples. This wound will be described in greater detail in the section on injury. There are no palpable masses on the chest. The abdomen is flat with no palpable masses. There is a 2-1/2 inch faint appearing well healed horizontally situated scar in the right lower quadrant suggestive of a prior appendectomy. The external genitalia are those of a circumcised male with no abnormalities noted and both

testicles palpated in the scrotal sac. The upper extremities are well formed without unusual scars or recent injury. The right upper arm is remarkable for a poorly defined monochromatic tattoo in the deltoid region. The lower extremities are symmetrical, well formed and free of unusual scars and evidence of recent injury.

The posterior surface of the body is remarkable for fixed livor mortis.

EVIDENCE OF MEDICAL INTERVENTION

The body is received with a clear plastic endotracheal tube inserted orally which is not secured. The body has received surgical betadine scrub evidenced on the anterior face, arms, chest and abdominal wall. A 7-1/2 inch thoracotomy incision has been made on the left #5/#6 interspace. Electrocardiogram leads are on the anterior and left lateral chest wall. Intravenous catheters have been inserted into the right and left antecubital fossae. Hospital identification is around the left great toe.

EVIDENCE OF INJURY

One perforating gunshot wound is observed to the chest.

The entrance gunshot wound is located on the anterior chest wall at 17-1/2 inches below the top of the head, 9 inches below the top of the shoulder and in the midline at the level of the nipple. The entrance wound is irregular measuring 2.3 cm X 2.4 cm. There is a wide area of abrasion surrounding the defect. The wound pathway is remarkable for soot and debris driven into the soft tissue depositing on the sternal surface. Dissection of the wound pathway reveals fracture of the sternum at the level of the #4/#5 rib interspace, multiple lacerations of the pericardial sac, multiple perforating lesions of the right auricle and right ventricle with extension of laceration into the interventricular septum, perforation of the aorta, perforation of the esophagus, fracture of the left transverse processes of thoracic vertebral bodies #8 and #9, followed by fracture perforation of the paraspinous processes of left ribs #8 and #9 posteriorly with the projectile exiting the body on the left side of the mid back occurring through a 8 mm slit-type exit wound located on the left side of the back at 18 inches below the top of the head and 1-1/2 inches left of the midline of the back. No projectile is recovered from the body.

The wound pathway is front to back and nearly horizontal.

Associated with the wound pathway is a left hemothorax of a measured residual 180 cc of liquid blood and a right hemothorax of a measured residual 35 cc of liquid blood, perforation of the esophagus, perforation of the aorta, avulsion of the right auricle and right ventricle on both

anterior and posterior surfaces along with deep laceration of the interventricular septum. The sternum is fractured and fragmented at the level of the #4/#5 rib space anteriorly and both right and left lungs are collapsed.

All of the gunshot wound residue is driven within the wound. There is no muzzle imprint or gunpowder stippling associated with the wound described above. The soft tissue underlying the entrance wound is remarkable for dark red coloration consistent with carbon monoxide infiltration.

INTERNAL EXAMINATION

The scalp is reflected forward via the usual bimastral incision revealing no evidence of galeal or subgaleal hematoma. The calvarium and basilar skull are intact and free of deformities and evidence of trauma. The dura mater reveals no evidence of subdural or epidural collections of blood. The leptomeninges covering the 1,360 gram brain are clear. External examination of the brain reveals slight swelling characterized by flattening of the gyri and narrowing of the sulci. The cerebellum reveals mild evidence of swelling. Serial coronal sectioning of the cerebral hemispheres, brainstem and cerebellum reveal no evidence of pre-existing lesions or intracerebral hemorrhage. The vessels forming the Circle of Willis are widely patent with no evidence of narrowing due to atherosclerosis. The pituitary gland is in its normal anatomic position and is unremarkable upon sectioning.

The neck organs are dissected in a layerwise fashion. The firm brown tongue is homogenous and free of bite marks or lacerations. The strap muscles are intact without laceration or hematoma noted. The intrinsic muscles of the larynx are intact and unremarkable. The hyoid bone, thyroid and cricoid cartilages are intact and free of injury. The thyroid gland is red/brown, bilobed, firm and homogenous upon sectioning. The larynx is opened posteriorly revealing thin pliable vocal cords with a tan mucosal surface. The pharynx is intact and not obstructed. The tracheal rings are not collapsed. The underlying spinal column is intact and free of injury.

The thoraco-abdominal region is explored through the usual Y-shaped incision. The midline fat has the greatest depth of 1.5 cm. Fracture to the sternum has been noted. The left thoracotomy incision encompasses the #5/#6 rib interspace. The vertebral column is remarkable for fracture of the transverse processes of thoracic vertebral bodies #8 and #9 at the costo-vertebral junction posteriorly. The vertebral column is opened at the level of the ninth thoracic vertebra. There is mild epidural hematoma collection noted with no impingement on the spinal cord. The

vertebral bodies are intact displaying no evidence of fracture or displacement. There are small right and left hemithoracic collections of liquid blood, the right measuring 35 cc and the left measuring 180 cc. The pericardial sac has been extensively lacerated and surgically opened for advanced resuscitation efforts. The abdominal organs maintain the usual anatomic relationships.

The heart weighs 290 grams. There has been extensive avulsion and laceration of the right atrium and right ventricular chambers. There is extensive laceration of the interventricular septum due to the perforating gunshot wound described previously. The remainder of the myocardium which is uninjured is firm pale brown and displays no evidence of scarring. The wound edges of the damaged myocardial fibers are hemorrhagic and friable. The coronary arteries are sectioned to reveal a slight narrowing by fatty atheromatous plaque build-up. The narrowing is less than 30% encroachment of the native luminal diameter. The heart valves are thin and pliable with no evidence of malformation or vegetation. The endocardial surface is focally hemorrhagic surrounding the gunshot wound pathway. Secondary missile fragments consist of fragmentation of the sternum. The fragments are identified within the myocardial tissue upon examination. The aorta is perforated at the approximate level of thoracic vertebra #8. The aorta is smooth walled with the intimal lining showing mild fatty atheromatous plaque build-up primarily in the abdominal regions. The great vessels given off the aorta are intact without evidence of injury.

The right and left lungs weigh respectively 240 grams and 260 grams. Both lungs appear collapsed with pink/tan glistening surfaces. Mild anthracotic pigment is present on the pleural surfaces. Upon sectioning, the lungs display a spongy parenchyma with no evidence of consolidation. There are no pre-existing mass lesions involving the pulmonary parenchyma. There is no evidence of unusual scarring. The pulmonary arterial tree is entirely free of thromboemboli. The bronchial airways are dissected to reveal no obstruction by foreign body or mucus plugs. There is mild anthracotic pigment deposition on the cut surfaces and within the intraparenchymal lymph nodes.

The liver is intact with a weight of 1,040 grams. The anterior margins are sharp and the capsular surface is red/brown and glistening. Serial coronal sectioning reveals no evidence of space occupying lesions and the hepatic parenchyma is homogenous. The gallbladder is intact and contains approximately 20 cc of thick green bile. Within the bile are three tiny cholelithiasis each measuring approximately 3 mm in diameter each. There is no obstruction to the bile duct. The pancreas is pink/tan, normally lobulated and free of gross abnormality. The pancreatic duct is patent.

The 150 gram spleen has a smooth gray capsule and a dark maroon homogenous parenchyma. There is no lymphadenopathy observed.

The right and left adrenal glands are unremarkable grossly and unremarkable upon sectioning.

The right and left kidneys weigh respectively as 130 grams and 100 grams. The renal capsules strip with ease revealing smooth red/brown cortical surfaces. Upon sectioning, there is good demarcation between the cortex and medullary regions. The collecting systems are mildly congested bilaterally. The renal pelves are unremarkable. The collecting systems are not obstructed or dilated. Both ureters follow a normal course to the urinary bladder which contains approximately 20 cc of clear urine. The bladder mucosa is gray/white and smooth. The prostate gland is firm, tan/brown with a rubbery consistency and smooth cut surfaces. The testicles are free of trauma. The pelvis is intact.

The esophagus has been perforated with the wound pathway surrounded by a purplish zone of contusion. The distal esophagus is free of lacerations and other mucosal abnormalities. Gastric contents consist of a minimal amount of tan mucus. There is no tablet or pill residue within the gastric mucosal lining. There is no evidence of ulceration of the gastric mucosal lining upon rinsing. There are normal rugal fold patterns to the mucosa of the stomach wall. The proximal small bowel contains a minimal amount of tan chyme material. There is no pyloric channel ulceration or abnormality of the proximal duodenum. The remainder of the small bowel is normal along the serosal surface without evidence of strangulation, herniation or obstruction to the small intestine. The large intestine is intact and unremarkable on the serosal surface. The appendix is not identified and there is a small area of fibrous scarring in the location of the cecum. The remainder of the ascending, transverse and descending colon are unremarkable. The anus is intact and soft brown stool is contained within the rectal vault.

With the exception of skeletal injury created by the gunshot wound pathway, there are no abnormalities noted to the muscular or skeletal system.

TOXICOLOGY: Samples of blood, urine, bile, vitreous humor and liver are obtained for toxicological analysis. One tube each of vitreous fluid, urine, chest blood, heart blood and bile are surrendered to (b)(6), (b)(7)(C) members of the Armed Forces Institute of Pathology (AFIP), who are in attendance for observation at the autopsy examination. Toxicology will be performed on these bodily fluid by AFIP, Toxicology Division.

HISTOLOGY: Representative sections of all major organs are retained in formalin.

Also in attendance at the autopsy are Detective (b)(6), (b)(7)(C) Metropolitan Police Department (Homicide) and (b)(6), (b)(7)(C) from the Naval Investigative Service.

On 17MAY96, reporting agent attended the autopsy of the body of ADM Jeremy M. BOORDA, USN, at the Office of the Chief Medical Examiner, District of Columbia (DCME). The autopsy was performed by (b)(6), (b)(7)(C) The Chief Medical Examiner. DCME autopsy number 96-0589 was assigned to the body. Beside DCME personnel, the autopsy was attended by Det. (b)(6), (b)(7)(C), Metropolitan Police Department (MPD), and evidence technician (b)(6), (b)(7)(C) MPD. Representatives from the Armed Forces Institute of Pathology (AFIP), Office of the Medical Examiner, were also present. The AFIP representatives, (b)(6), (b)(7)(C) MC, USA, (b)(6), (b)(7)(C) MC, USN, and photographer, (b)(6), (b)(7)(C) arrived after the autopsy had begun.

The body reflected medical intervention by hospital personnel, with I.V. tubes in both arms, and a roughly sewn incision from near the center of the chest to the left side. R.A.M. medical pads were on each chest wall. Lividity was noted on the back side of the body. (b)(6), (b)(7)(C) informed reporting agent the x-rays of the body were negative for metal objects such as a bullet. The hands had obviously been cleaned. Officer (b)(6), (b)(7)(C) informed reporting agent that gunshot residue (GSR) swabs had been taken of the hands at the hospital by MPD personnel. Clothing taken from a bag accompanying the body included white trousers with a belt, white socks, white shoes, white underwear, a surgical towel and another red colored rag. Many of these items appeared blood soaked or had apparent blood on them. The items were photographed by DCME personnel, and their disposition was handled by MPD.

The autopsy was discontinued until the remaining clothing held in evidence by MPD was available. The autopsy resumed when the clothing arrived. The clothing consisted of a black Navy jacket, a bloodied white polyester shirt, and a bloodied T-shirt. The clothing was laid out and examined by Dr Carter. It was photographed by DCME personnel. Although soot from a gunshot was not noticeable on the black jacket, it had been cut, apparently by hospital personnel. An apparent exit hole was present in the back of the jacket. The white shirt had apparent soot marks around the hole on the front, and a hole in the back of the shirt was present, with no such soot mark apparent. The T-shirt also had an exit hole in the back.

A tattoo of a figure not readily obvious, was noted on the right upper arm. The figure appeared to be of an incomplete circular object, roughly heart shaped. A large hole, nearly 1 inch in diameter, was apparent in the middle of the chest. (b)(6), (b)(7)(C) described what appeared to be soot consistent with a gunshot deep into the wound. (b)(6), (b)(7)(C) was later able to determine the wound track. After going through the sternum, the bullet passed through the right side of the heart, through the esophagus, through the juncture of the 8th and 9th rib at the vertebral column, exiting a smaller defect in the back of the body. An entrance wound in the center of the chest was determined to be 17 1/2 inches from the top of the head, with the exit wound being 18 inches from the top of the head. Further, the exit wound was determined to be approximately 1 1/2 inches left of midline.

It was noted that the lack of an appendix was confirmed by a scar consistent with a previous appendectomy. Tissues samples were taken by (b)(6), (b)(7)(C) for later examination. Some body fluids and tissue samples were provided to AFIP for toxicological analysis. Evidence technician Wallace provided reporting agent with a set of fingerprints taken from the body. Polaroid photographs of the body, damage to the heart, and military items from the clothing were provided by the AFIP photographer. The fingerprints and photographs were later provided to the case agent, (b)(6), (b)(7)(C). Arrangements were made with the DCME photographer, (b)(6), (b)(7)(C) to obtain copies of the photographs taken during the autopsy procedures. These photographs will be documented by separate Investigative Action.

At the conclusion of the autopsy, (b)(6), (b)(7)(C) verbally stated it was her opinion the cause of death was from a gunshot wound to the chest. She also stated it was consistent with a self inflicted contact wound. The manner of death was determined to be suicide. (b)(6), (b)(7)(C) agreed to provide a copy of the autopsy report, when completed, if a letter requesting the report is presented to her.

Narrative

The clothing which accompanied the decedent consisted of a pair of white shoes, white socks, white blood soiled trousers with a white belt and blood soiled underwear. The remaining clothing which had been recovered from the hospital was subsequently transported from the Crime Scene Examination Section to the autopsy to permit Doctor (b)(6), (b)(7)(C) the opportunity to view them. These clothes consisted of a waist length black uniform jacket, white uniform short sleeve shirt and a white t-shirt. The uniform shirt displayed a single gunshot wound which a large amount of soot and residue around the entrance site. The entrance hole to the shirt, which is 100 % polyester, had melted from the gunshot.

Exterior examination noted medical intervention which consisted of intravenous lines insert in both anterior elbows and a sutured lateral incision below the left nipple. It should be noted immediately after the Admiral was pronounced gunshot powder residue was observed around the wound of the chest and on both webs of each hands. At the time of the autopsy there was no visible soot observed. This was due to swabs samples being taken at the hospital by evidence technicians. There was also an approximately 2" old scar on the right lower abdomen area.

The major evidence of trauma consisted of a single gunshot wound to the chest (in/out). The wound is to the midline, approximately 17 1/2" from the top of the head at level with the nipples. There was redness observed the entrance wound site. The wound defect measures approximately 1" with a 1 centimeter abrasion collar. The wound is consistence of a "Contact". The enlargement of the entrance wound is possible due to "blow back" from the weapon.

The autopsy itself revealed the projectile penetrated the sternum. The outer bullet hole defect is smaller to comparison to the inner portion of the sternum. The 5th rib is cut out and an incision is made between the 4th and 5th intercostal space (hospital induced trauma). The projectile causes massive damage to the right side of the heart and perforated the esophagus. The projectile takes bone fragments from the sternum into the heart. The projectile exited the rear of the back, just to the right of the spine. The 8th and 9th ribs at the spine are fractured.

Further examination revealed three (3) small gallstones found in the gallbladder. There was no right appendix. Examination of brain noted it was swollen and soft. The projectile direction of travel is front to back, nearly horizontal. The cause of death was determined to be Gunshot wound to Chest (Self-Inflicted). The manner of death was rued a Suicide. The aforementioned information is general in content, for specific documentation, refer to the Autopsy Protocol supplied by Doctor (b)(6), (b)(7)(C) Chief

After his arrival at the residence, approximately 10-15 minutes later, (b)(6), (b)(7)(C) stated he received a page from (b)(6), (b)(7)(C) stated he answered the page almost immediately by telephoning the CNO's office at (b)(6), (b)(7)(C) and spoke with (b)(6), (b)(7)(C) During this telephone conversation, (b)(6), (b)(7)(C) stated he informed (b)(6), (b)(7)(C) that he was going to re-position the CNO's official vehicle. The telephone record for (b)(6), (b)(7)(C) reveals the aforementioned telephone call was made at 1324, on 16May96.

Case Summary

1. Investigation was initiated on 16May96, following receipt of information at approximately 1400 from Naval District Washington (NDW), Police that V/BOORDA had been found lying on his back in a grassy area on the grounds of his residence (Quarters A, east lawn area, Washington Navy Yard), suffering from a gunshot wound. Upon arrival at the scene minutes later, Metropolitan Police Department Washington, DC (MPDC) personnel had secured the scene and V/BOORDA was enroute to DC General Hospital. V/BOORDA reportedly suffered a single gunshot entrance wound to the middle of his chest. At the scene, it was agreed that MPDC would be the lead investigative agency. NDW Fire Department personnel reportedly attempted to resuscitate V/BOORDA by performing CPR at the scene prior to transporting him. Subsequently, V/BOORDA was pronounced dead at DC General Hospital at approximately 1430 by the head of the Trauma Department. Medical personnel confirmed the gunshot wound to V/BOORDA's chest resulted in an exit wound on his back.

2. Reportedly, on 16May96, V/BOORDA drove himself from the Pentagon, arriving at his residence at approximately 1320. No one witnessed the shooting; however, military personnel, to include V/BOORDA's driver, marine security post #2, personal aide to the Commandant NDW, and housekeeper, were in the vicinity. (b)(6), (b)(7)(C) an unarmed USMC sergeant sitting in V/BOORDA's official vehicle in front of the residence, reportedly witnessed V/BOORDA falling to the ground at the scene. (b)(6), (b)(7)(C) immediately notified the nearby guard post (#2) to call 911. A Smith & Wesson .38 caliber five shot revolver serial #AYV2602 was recovered near V/BOORDA's feet, loaded with four live rounds of .38 caliber Winchester +P hollow point nose ammunition and one spent casing/shell under the hammer.

3. A search of V/BOORDA's residence, revealed a typewritten note addressed to (b)(6), (b)(7)(C) and "To My Sailors". A second note was addressed to (b)(6), (b)(7)(C). The original notes were seized as evidence by the MPDC crime/death scene technicians. The first note mentioned that V/BOORDA was being accused of wearing combat devices on two ribbons that he did not rate. The second note talked about V/BOORDA allegedly stating "I'm letting you down but I simply cannot go on with my honor and integrity questioned in such a public way." Additionally,

28. On 17May96, (b)(6), (b)(7)(C) USN, PSD Crystal City provided V/BOORDA's hard copy Service Record Book (SRB) to PA (b)(6), (b)(7)(C). V/BOORDA's SRB was placed into the NCISFO Washington, DC, evidence custody locker under NCIS log #154-96.

29. On 17May96, (b)(6), (b)(7)(C) Office of Attending Physician, U.S. Congress, Washington, DC, provided V/BOORDA's dental records and dental castings to PA (b)(6), (b)(7)(C). Both items were placed into the NCISFO Washington, DC evidence custody locker under NCIS log #154-96. Six original handwriting samples/known writings to include one Consent to Periodontal Surgery and five Dental Health Questionnaires were seized from V/BOORDA's dental records and placed into the NCISFO Washington, DC, evidence custody locker under NCIS log #153-96. Copies of the original handwriting samples are appended as exhibit (46). On 20May96, command provided five additional notes or correspondence with original samples of V/BOORDA's handwriting which were placed into the NCISFO Washington, DC, evidence custody locker under NCIS log #156-96. All handwriting samples which included signatures of V/BOORDA were subsequently transferred to the custody of MPDC for laboratory analysis.

30. On 17May96, (b)(6), (b)(7)(C) Pentagon, was interviewed by Special Agent in Charge (SAC) (b)(6), (b)(7)(C), NCISFO Washington, DC, and (b)(6), (b)(7)(C). (b)(6), (b)(7)(C) advised that his relationship with V/BOORDA was professional in nature and that he had no personal contacts with him. He related that on 16May96, he attended a meeting with V/BOORDA in the CNO's office. Several other staff members were in attendance at the meeting which lasted for approximately one hour starting at 1000. Later, (b)(6), (b)(7)(C) advised he received word that (b)(6), (b)(7)(C) was asking questions of senior Pentagon officials about what kind of person was V/BOORDA. Bureau Chief, to find out if he had planned to ask V/BOORDA specific questions during the scheduled interview. (b)(6), (b)(7)(C) related (b)(6), (b)(7)(C) informed him that he had some specific questions concerning two personal awards with Combat V's worn in the past by V/BOORDA. Next, (b)(6), (b)(7)(C) stated he called the CNO's office, asking to see V/BOORDA right away. About 1215, (b)(6), (b)(7)(C) briefed V/BOORDA. He indicated V/BOORDA's response to the news was... "I know, (b)(6), (b)(7)(C) we'll simply tell the truth." Amplifying details are contained in exhibit (48) (b)(6), (b)(7)(C) statement. Additionally, (b)(6), (b)(7)(C) provided a copy of a recent Navy Times article (exhibit (49)) which criticized V/BOORDA. (b)(6), (b)(7)(C) also provided copies of citations awarded to V/BOORDA, regarding his tour of duties with the USS John R. Craig (DD 885), circa 10Apr65-10Aug65, and under U. S. Pacific Fleet, from 15Dec71 to 20Feb73. A review of these citation awards, failed to mention whether V/BOORDA was authorized to wear the Combat V's. A copy of the citation awards are exhibits (50) and (51) respectively.

32. On 21May96, (b)(6), (b)(7)(C) CNO, was interviewed by PA Goldstein. (b)(6), (b)(7)(C) stated he first saw V/BOORDA on 16May96 at approximately 0930-0940. (b)(6), (b)(7)(C) opined V/BOORDA appeared and sounded upbeat and normal in all respects. Regarding 16May96, (b)(6), (b)(7)(C) explained he did not have an opportunity to speak with V/BOORDA "one on one." (b)(6), (b)(7)(C) advised he was aware V/BOORDA departed the Pentagon some time after 1200 on 16May96. A copy of (b)(6), (b)(7)(C) sworn statement is exhibit (52).

AGENT'S NOTE: Although (b)(6), (b)(7)(C) was interviewed on 21May96, his statement was not signed until 23May96, due to other commitments in his schedule.

33. On 21May96, a Bureau of Alcohol, Tobacco and Firearms (BATF) trace revealed the seized revolver was purchased from Smith and Wesson by Ashland Shooting Supplies, 110 Baird Parkway, Mansfield, Ohio, on 01Jan88, and subsequently traced to the Naval Investigative Service, Seattle, Washington, on 10Feb88. A report of the BATF trace is exhibit (53).

34. On 22May96, (b)(6), (b)(7)(C) was interviewed by PA (b)(6), (b)(7)(C) and Reporting Agent (RA). (b)(6), (b)(7)(C) stated he attended a Flag Officer slating meeting with (b)(6), (b)(7)(C) and V/BOORDA, on 16May96. (b)(6), (b)(7)(C) believed his meeting with the CNO did not get underway until approximately 1130 and ended about 1215. According to (b)(6), (b)(7)(C) during the meeting they discussed personnel issues and the new Flag Orientation Course. V/BOORDA reportedly informed him that he (V/BOORDA) planned to speak during the next Flag Orientation Course, specifically developing and orchestrating the theme of morality and ethics, etc. (b)(6), (b)(7)(C) indicated the meeting ended upbeat and at no time did he believe V/BOORDA was despondent or overly concerned about any professional or personal issues. (b)(6), (b)(7)(C) stated he was unaware V/BOORDA was going to be questioned by reporters for

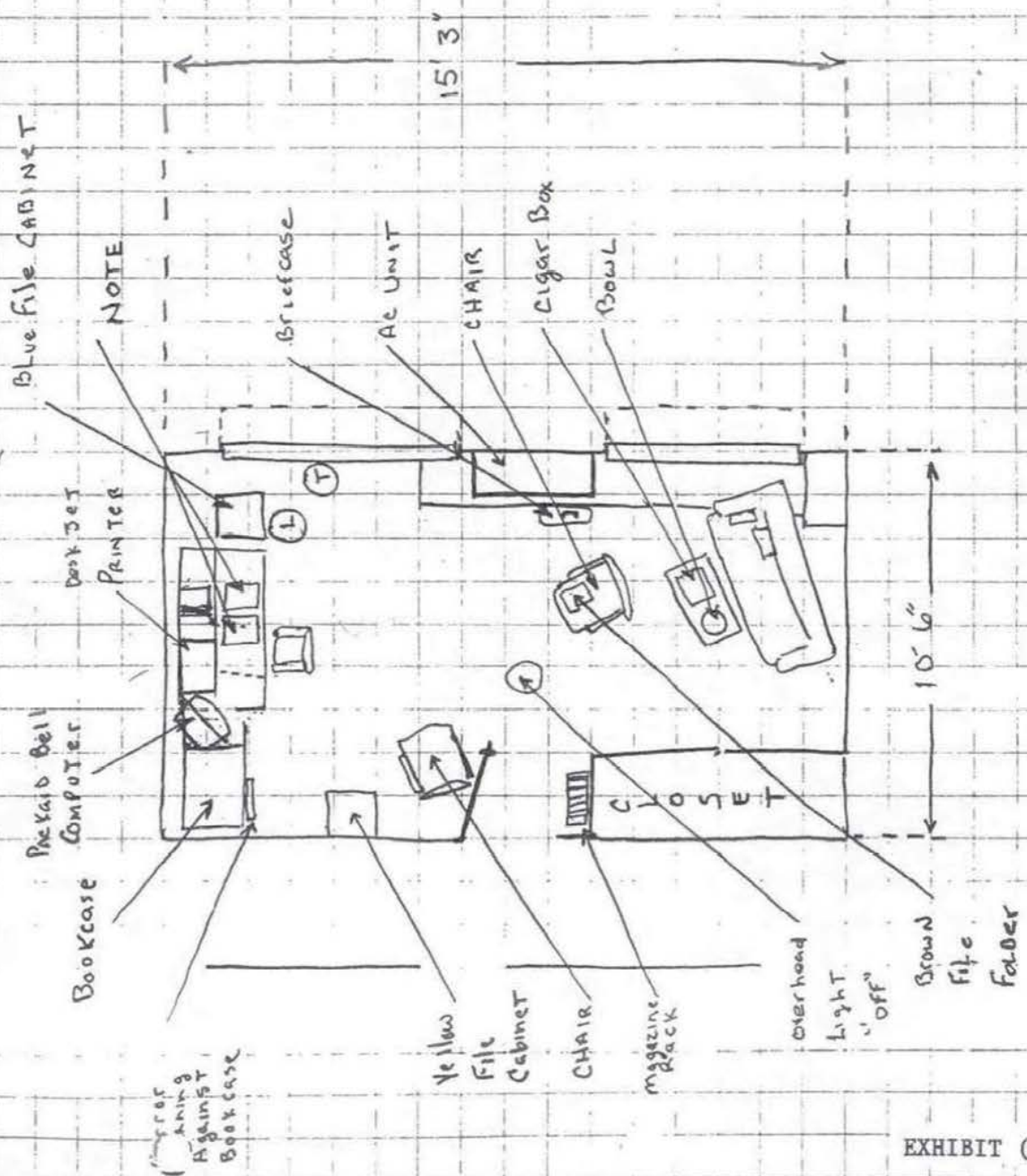

I, (b)(6), (b)(7)(C), make the following free and voluntary statement to (b)(6), (b)(7)(C), whom I know to be a Special Agent of the United States Naval Criminal Investigative Service. I make this statement of my own free will and without any threats made to me or promises extended. I fully understand that this statement is given concerning my knowledge concerning Admiral Jeremy Boorda's activities on 16MAY96.

For the purpose of identification, I am a (b)(6), male, (b)(6), tall, weighing approximately 158 pounds. I have (b)(6), hair and (b)(7)(C) eyes. My social security number is (b)(6), (b)(7)(C) and I was born on (b)(6), (b)(7)(C).

As background, I have been assigned to Admiral Boorda as (b)(6), (b)(7)(C) since FEB90.

Between 1300 and 1330, I was working at Admiral Boorda's residence located at Quarters A, Tingey House, Naval District Washington, Washington, DC. when I received a telephone call from (b)(6), (b)(7)(C) stated that Admiral Boorda will be arriving at his house in 10 minutes. A few minutes later, Admiral Boorda arrived alone driving his official vehicle. He exited the vehicle dressed in his white uniform and black jacket. He was not carrying anything; the Admiral left his hat in the car. He gave me the keys to the vehicle and told me to place them on the side table by the main entrance. Admiral Boorda then climbed the back stairs to the second floor. Approximately 5 minutes later, the Admiral's additional (b)(6), (b)(7)(C) returned from the Navy Federal Credit Union. At about this time, we both heard the upstairs toilet flush. (b)(6), and I waited in the kitchen, because we expected the Admiral to ask up to make him and sandwich. At approximately 1400, (b)(6), (b)(7)(C) called to discuss the upcoming party beginning on 23MAY96. Admiral Boorda and I picked up the receiver at the same time; I heard the admiral say "hello". Admiral Boorda listened to my discussing the party arrangements with (b)(6), (b)(7)(C) for approximately 1 minute; I know this, because the phone light blinks whenever someone picks up an extension. Admiral Boorda hung up the receiver and (b)(6), (b)(7)(C) and I discussed the upcoming event for about 7 to 10 minutes. After (b)(6), (b)(7)(C) telephoned, left to go to the Bolling Air Force Base Commissary to shop and to pick-up the Admiral's drycleaning. 20 minutes after I spoke to I received a call from asking for Admiral Boorda; this was between 1425 and 1430. I placed call on hold, and I attempted to find Admiral Boorda by buzzing the various upstairs rooms. I

first rang the study room, then the dressing room, and then his bedroom. When there was no answer, I went to the second floor to look for him. When I could not find him, I left the house to look for Admiral Boorda in the yard - it was at this time I saw an ambulance and police officers, who told me to go back in the house. Two policeman came in the house and told me they wanted to search the house; they asked how many people were in the residence. I said myself, the Admiral's

I accompanied the policemen while they searched the rooms upstairs. While an officer was searching Admiral Boorda's study, I noticed some papers on his desk. I went downstairs and saw NCIS Special Agent

and told him there were some papers lying on the Admiral's study desk. Agent then went to the upstairs study.

Special Agent asked me if I heard or saw anything unusual. I did not hear anything out of the ordinary. I spent most of the day in the kitchen; the kitchen noise is usually loud, because it is next to a main road traveled by vehicles. I did not notice any change in the Admiral's demeanor. At approximately 0600, the Admiral and came downstairs in their sleeping clothes, and I served them coffee in the kitchen. The Admiral told me he would be leaving for work later than usual and asked me to wait for message traffic. Admiral Boorda and went back upstairs about 5 minutes later. I next saw the Admiral at approximately 0800, when he came downstairs in his uniform to get another cup of coffee. He asked me if the message traffic had arrived yet. I said no. He went back upstairs. The messages were later delivered by the Admiral's driver at approximately 0830. When the driver arrived, the Admiral came downstairs and got the messages. The driver then left and returned approximately 45 minutes later to take the Admiral to work. Shortly after the driver left, I went to the second floor study to take Admiral Boorda a cup of coffee. The Admiral was seated at his desk and was speaking to his wife, who was seated to her husband's immediate left. The next time I saw Admiral Boorda was at approximately 0900. The Admiral was standing on the stair landing by his two briefcases. I went upstairs, grabbed the Admiral's two briefcases, and took them to the Admiral's driver, who had arrived by that time. came downstairs also, as she was preparing to visit her daughter in Burke, VA. Before the Admiral left for work, he told his wife that he will be returning home late tonight at approximately 2000, because he had a Joint Chiefs of Staff meeting.

At or around 0600, Admiral Boorda and came downstairs for coffee. I did not see or notice any changes in Admiral Boorda's demeanor at this time or anything unusual. Admiral Boorda informed me he was going to work at a later time than usual

Admiral Boorda departed for work at approximately 0900, on 16May96. Subsequently, at approximately 1300-1330, I was notified by that Admiral Boorda was on his way home. Shortly thereafter, Admiral Boorda arrived and I met him at the front door. Once he entered the front door, he handed me the key to his official vehicle. He then asked me where was . I informed him I went to visit his . At this time, I did not notice any changes in Admiral Boorda's demeanor. Admiral Boorda immediately went upstairs to the second floor. I did not follow Admiral Boorda. My colleagues and I are not allowed to go up to the second floor/level unless requested by a family member.

They split up in different directions and I followed one of them. I also told them was the only other person inside the residence that I knew of. On 16MAY96 at 1715, an inventory of the vehicle assigned to the Chief of Naval Operations (CNO), ADM J.M. Boorda, was conducted. The inventory was assisted by Officer (b)(6), (b)(7)(C) Metro Crime Lab (MCL), Metro Police Department (MPD). The following information pertains.

The vehicle inventoried was a 1995 Lincoln Towncar, color blue. Washington DC tag 140-156. The CNO's primary driver is (b)(6), (b)(7)(C) USMC, Telephone: Office (b)(6), (b)(7)(C) Pager: (703) (b)(6), (b)(7)(C). The CNO's alternate driver is (b)(6), (b)(7)(C) USMC. The vehicle was parked in the circular driveway directly in front of the residence of the CNO, Washington Navy Yard, Washington, DC. The exterior and interior of the vehicle was observed to be extremely clean. The vehicle was equipped with three mobile telephones headsets with two assigned telephone numbers. The drivers mobile telephone number was (b)(6), (b)(7)(C). A secured STU-3 mobile telephone was noted in the back seat with assigned number (b)(6), (b)(7)(C). A second STU-3 headset was also in the front seat directly beside the drivers mobile telephone. One portable cellular telephone was located in the front seat of the vehicle, however, it was learned it was the personal property of (b)(6), (b)(7)(C). The cellular telephone was seized and relinquished to Officer (b)(6), (b)(7)(C) MCL for the subsequent entry into the MPD evidence custody system.

Several memorandum notes, business cards, laminated cards containing telephone numbers and a six page handwritten document that appeared to be notes were located in the back seat area. These items were seized and entered into the Naval Criminal Investigative Service (NCIS) evidence custody system under log number 148-96. Copies of the items seized are appended as enclosures (1) through (4).

Contents of the trunk were inventoried and the following items noted:

- (1) spare tire
- (2) blanket
- (3) flares
- (4) box of napkins
- (5) cardboard box containing several small decorative bags each containing small gifts, i.e., glass figurine, small porcelain vase, scarfs, and pewter hummingbird.
- (6) umbrella
- (7) Bottle of Windex glass cleaner

No additional items of significance were noted.
